MAILING LIST RENTAL AGREEMENT**

**In consideration of the covenants contained herein, the parties agree as follows:**

1. The American Association of Medical Dosimetrists (AAMD) shall make available to \_\_\_\_\_ (hereinafter referred to as the Lessee) a list of the names and addresses of its members for the price of \$\_\_\_\_\_ on the terms and conditions contained in this Agreement.
2. The list may not be used in connection with any communication, which, in the opinion of the AAMD, would tend to mislead, misinform, or deceive or which is distasteful in content or presentation.
3. The list may be used only for mailing purposes. Correspondence may not be personalized with names obtained from the list. User follow-up by telephone or personal contact to a response to a mailing is not a prohibited use.
4. Prior to any mailing, the Lessee shall furnish to the AAMD a copy or sample of all matter to be mailed. The AAMD in its discretion (which it agrees to reasonably exercise) may disapprove any part or all of such matter for mailing.
5. The Lessee shall indemnify and hold the AAMD harmless against all claims, damages, costs, expenses, including attorney's fees, arising out of the use of the list, including claims for infringement of copyright, trademarks, or trade man, defamation, and misappropriation of proprietary rights.
6. The Lessee shall use the list one time only (and within six months of issue) and must not copy the list or any portion thereof, or extract or retain any information there from. The Lessee shall not permit the list to pass into the hands of any other person or entity.
7. It is expressly understood and agreed that the AAMD's right, including, but not limited to common law and statutory rights of literary property and copyright in the AAMD's list and the data contained therein are not assigned or released as a result of this Agreement, but are reserved and retained by the AAMD subject not be limited use permitted under this Agreement.
8. The list and information thereon at all times is and remains the sole property of the AAMD and in no event shall user divulge to anyone, make copies of (including data entry, scanning or any other form of digitizing) or use same in any way, except as may be permitted in writing by the AAMD.
9. For any breach of the Agreement, the Lessee shall be liable to the AAMD for all damages, including reasonable attorney's fees, costs, and expenses, including expenses incurred in investigation, and loss of income.
