Dear Fellow Applicant:

The AAMD Fellows are waiting to assist you with all aspects of the application process.

Please follow the steps below as you apply for AAMD Fellows Elevation:

- 1) Please select and secure a Fellows sponsor before you begin the application process. You must have a sponsor who is a current Fellow of the AAMD. If you need assistance securing a sponsor, contact the Fellows Chairperson.
- 2) Once you have secured a sponsor, you and the sponsor must review the blank application, Documentation Guidelines, Fellow Point Evaluation Scale, Application Guidelines, and the Medical Dosimetry Fellow Glossary. This must be done **before** you gather your documentation, as this will allow you to address any questions.
- 3) The application must be submitted on the current Fellow Application. Reformatting the online application is not acceptable. If additional space is needed, attach a separate sheet. The application and all documentation must be submitted electronically. Please check with the AAMD office and/or the sponsor to make sure the application online is the most current.
- 4) Documentation of each activity must be included in the application for points to be awarded. Please reference the Fellow Point Evaluation Scale and the Medical Dosimetry Fellow Glossary for details of appropriate documentation. Please note only activities that are directly related to Medical Dosimetry or Radiation Oncology will be considered.
- 5) Documentation of your activities can be time consuming, so please allow ample time for this. Your documentation will need to be scanned and sent electronically with your completed application.
- 6) Communicate with your sponsor regularly during the process of application and documentation. Your sponsor will be able to help clarify any questions or concerns you might have as you gather your documentation.
- 7) The completed application with documentation must be submitted to your sponsor by October 1. The sponsor will review and verify the application. The sponsor may or may not ask for additional documentation or clarification to assist you in completion of the application. The sponsor will sign the application once he/she deems it complete and ready for Fellows committee review. The deadline for you to receive the reviewed application is November 1. If you have not received the reviewed application by November 1, you should immediately contact the Fellows Chairperson.
- 8) You must submit the \$100.00 processing fee to the AAMD office by the October 1 deadline. This must be done electronically via the website. A link is provided on the Fellows web page

Documentation Guidelines for Fellow Application

There are six major categories:

- A. Professional Experience
- B. Education
- C. Professional Activities
- D. Scholarly & Professional Contributions
- E. Awards, Scholarships, and Grants
- F. Membership

The minimum point requirement must be met in each category to be eligible. All accomplishments must be met by the time of application in order to be eligible.

Required documentation includes but may not be limited to: [refer to glossary for specific details]

- Job description with title from employer verifying work experience and dates (up to maximum number of years allowed)
- Copy of educational program certificates
- Copy of diploma for degrees
- Copy of current MDCB certification
- Copy of current Imaging/Radiation Therapy certification(s)
- MDCB CE record
- Letter from professional organization verifying offices held with dates
- Copy of brochure/program or letter from CE sponsor verifying dates and hours of lectures
- Copy of 1st page of article and copy of cover of publication (author position must be visible)
- Copy of book cover or 1st page of chapter (author position must be visible)
- Copy of 1st page of article and copy of cover of other publication (author position must be visible)
- Copy of award(s) or letter(s) verifying awards
- Copy of membership or letter(s) verifying membership length with dates

Application

- Completed application to be received by your sponsor no later than **October 1** of the year prior to elevation
- Receive reviewed application from sponsor no later than **November 1**
- Reviewed application must include sponsor signature and date
- Application Deadline: application must be received no later than **October 1** of the year prior to the anticipated elevation.

- \$100 Fee paid to AAMD

Application Guidelines

1. Minimum number of points required for consideration for elevation is 77.
2. Activities or service not appearing on the Fellow Point Evaluation Scale will not be reviewed or awarded point(s).
3. No points below 0.5 will be accepted for points on the application.
4. All applications must be submitted on the current Fellow Application.
5. Only full years of service will be used to award points.
6. No points are awarded for works-in-progress.
7. Points awarded for CE participation will be figured to the nearest whole number.
8. Points awarded for disciplines in imaging sciences and radiation therapy.
9. Letters from employers are needed only to support the maximum number of points awarded. There is no need to obtain letters from all previous employers.
10. Only lectures presented as an AAMD/ASRT/ASTRO/AAPM/ACMP or affiliate level conference can be claimed.
11. Points awarded for publication of an article in a journal are based on the position of the author and must be peer-reviewed.
12. Points awarded for the publication of books or chapters are based on the position of the author/editor.
13. Documentation for points awarded for publication of books and articles must include a copy of the first page of the article or title page of book and a copy of the cover of the publication.
14. AAMD active member of 10 years of consecutive membership: The first 10 years do not count for points on the application. The AAMD Member Profile should be used to verify membership. An appropriate letter from the AAMD should be used to verify membership.
15. When a member of the committee is acting as a sponsor of a current Fellow applicant, he or she will be excused from the voting process on that applicant.
16. In order for an applicant to be elevated, he or she must receive a unanimous confirmation of eligibility by those members evaluating the application, based on the Fellow point evaluation scale and guidelines.
17. Members of the committee will complete an applicant evaluation form for each applicant. These are sent to the Chairman of the Fellows Committee for tabulation and recommendations to the AAMD Board of Directors.
18. MDCB certification is required for fellowship.

Fellow Point Evaluation Scale

Fellow Glossary

Category A

- 1. Staff Medical Dosimetrist:** full time work experience (employment) as a staff medical dosimetrist.
- 2. Workplace Leadership:**
 - a. Senior/Lead Medical Dosimetrist:** full time work experience (employment) as a senior or lead medical dosimetrist. This does not include a supervisor or manager of a medical dosimetry work area. Documentation must clearly demonstrate leadership title with job description.
 - b. Supervisor/Manager/Director:** full time work experience (employment) as a supervisor, manager, or director of a medical dosimetry work. This does not include a senior or lead medical dosimetrist. Documentation must clearly demonstrate leadership title with job description.
- 3. Medical Dosimetry Educator:**
 - a. Clinical Instructor:** full time work experience (employment) as a clinical instructor for a medical dosimetry educational program.
 - b. Clinical Preceptor:** full time work experience (employment) as a clinical preceptor for a medical dosimetry educational program.
 - c. Educational Coordinator:** full time work experience (employment) as a clinical educational coordinator for a medical dosimetry educational program.
 - d. Program Director:** full time work experience (employment) as a program director for a medical dosimetry educational program.
- 4. Research, Sales, Applications:** full time work experience (employment) as a research medical dosimetrist, a sales representative in medical dosimetry, or a vendor applications specialist in medical dosimetry.

Category B

- 1. Certificate Program:** graduate of a certificate program in imaging sciences, radiation therapy, or medical dosimetry. Required documentation includes a certificate, diploma copy, or official transcripts.
- 2. Associate Degree:** graduate of an accredited associate degree program. Required documentation includes a copy of the degree or official transcripts.
- 3. Baccalaureate Degree:** graduate of an accredited baccalaureate degree program. Required documentation includes a copy of the degree or official transcripts.
- 4. Master's Degree:** graduate of an accredited master's degree program. Required documentation includes a copy of the degree or official transcripts.
- 5. Doctorate Degree:** graduate of an accredited doctoral degree program. Required documentation includes a copy of the degree or official transcripts.

- 6. MDCB Certification:** currently certified by the Medical Dosimetrist Certification Board (MDCB). MDCB certification is required for fellowship.
- 7. Imaging Sciences/Radiation Therapy Certification:** currently certified by appropriate credentialing body. List current certificate for each discipline (e.g., imaging sciences, radiation therapy)
- 8. MDCB Accredited Continuing Education Participation:** part of the continuing education program through the MDCB renewal procedure. MDCB requires 50 CE credits obtained in each 5 year renewal period. After certification, list each 5 year renewal CE period. Applicant must provide proof of initial year of certification, followed by each 5 year CE renewal period. This documentation must be from the MDCB.

Category C

- 1. AAMD Presidential Term:** service in the Presidential role (to include President-elect and/or Immediate Past President) of the AAMD.
- 2. AAMD Board of Directors:** Non-presidential board of director positions. Service on the AAMD Board of Directors for the required term of each position. List all positions served for each term. List each term if you have served more than one term.
- 3. AAMD Committee Co-Chair:** service as an AAMD Committee Co-Chair. List each committee co-chair position. Points awarded per two year term appointed by the Board of Directors.
- 4. AAMD Committee Member:** service as an AAMD Committee member, 2009 and after. List each committee member position. This must be confirmed by a co-chair of the committee. Points awarded per two year term.
- 5. AAMD Liaison to an External Organization:** service as an AAMD liaison to an external organization or association. Specify the liaison position. Points awarded per each liaison position appointment.
- 6. AAMD Regional Meeting Co-Chair:** service as an AAMD Regional meeting co-chair. Regional Directors cannot claim credit in this category if the meeting was held during their term. Points awarded per meeting co-chaired.
- 7. AAMD Annual Meeting Co-Chair:** service as an AAMD Annual Meeting Co-Chair prior to the year 2007 only. After 2007, this became the responsibility of the ACC Co-Chairs. Points awarded per meeting co-chaired.
- 8. Editor for the Medical Dosimetry Journal:** service as the Editor-in-Chief for the medical dosimetry journal.
- 9. Editorial Board for the Medical Dosimetry Journal:** service as a member of the editorial board for the medical dosimetry journal.
- 10. AAMD Education and Research Board of Trustees:** service on the AAMD Education and Research Board of Trustees. This does not include the AAMD organization board of directors. The service on the board of trustees must be documented.

Category D

Documenting all lectures is required. The MDCB began approving AAMD activities in 1990. If a lecture was given from 1990 to the present, then approval of the lecture from the MDCB must be included with your documentation for that lecture. Prior to 1990, the documentation of your lecture can be in the form of a certificate from the meeting, thank you letter, note for being a speaker, etc. This applies for lectures at the national and regional levels in the field of radiation oncology and medical dosimetry. This information must be included to claim points for each lecture.

Section I

- 1. Lecturer at the National Level:** professional medical dosimetry lecturer (face-to-face or electronically) at the national level. Lecture at AAMD, ASTRO, AAPM, ACMP, AEIRS, or ASRT annual meetings.
- 2. Lecturer at the Regional Level:** professional medical dosimetry lecturer at the regional level. Lecture at AAMD, ASTRO, AAPM, ACMP, AEIRS, or ASRT regional meetings.

Section II

- 3. Publication in Medical Dosimetry Journal:** author or co-author of a publication in the medical dosimetry journal.
- 4. Publication in Medical Dosimetry Journal:** co-author of a publication in the medical dosimetry journal excluding first co-author.
- 5. Publication of Books:** sole author of a book specifically to the field of radiation oncology.
- 6. Publication of Books:** contributing author of a book specific to the field of radiation oncology.
- 7. Non-AAMD Journal Publication:** sole author of a medical dosimetry publication in a journal other than the Medical Dosimetry Journal. Must be peer-reviewed publication to qualify of points.
- 8. Non-AAMD Journal Publication:** contributing author of a medical dosimetry publication in a journal other than the Medical Dosimetry Journal. Must be peer-reviewed publication to qualify of points.
- 9. AAMD Curriculum Guide:** contributing author for the AAMD Medical Dosimetry Educational Curriculum Guide. Documentation as listed author on curriculum guide publication.
- 10. Other Publication:** contributing author of a publication in the field of radiation oncology or medical dosimetry. Examples include organization white papers, organizational task group reports, trade publications, etc.

Section III

- 11. Medical Dosimetry Poster Presentation at the National Level:** author or co-author of a medical dosimetry poster presentation displayed at a national AAMD, ASTRO, AAPM, ACMP, or ASRT meeting.
- 12. Medical Dosimetry Poster Presentation at the National Level:** contributing author, excluding first co-author, of a medical dosimetry poster presentation displayed at a national AAMD, ASTRO, AAPM, ACMP, or ASRT meeting.
- 13. Reviewer for the Medical Dosimetry Journal:** service as a reviewer for the articles submitted to the medical dosimetry journal. Documentation includes list of peer-reviewed articles exported from your Elsevier reviewer account or a letter from the Editor with article ID# and dates. De-identifying the article title/author is appropriate to ensure blind review process.

Category E

- 1. Varian/AAMD Award of Excellence:** recipient of the Varian or AAMD Award of Excellence.
- 2. AAMD Writing Competition Winner:** 1st, 2nd, or 3rd place winner of the AAMD Writing Competition. This is the professional, non-student competition.
- 3. AAMD Poster Presentation Competition Winner:** 1st, 2nd, or 3rd place winner of the AAMD Poster Presentation Competition. This is the professional, non-student competition. Years 1998 – 2003 only.
- 4. Grant Recipient:** recipient of a grant related to the field of radiation oncology. Minimum monetary award of grant must be \$5000.00. "Grant in kind" are not eligible towards AAMD Fellow points.

Category F

- 1. AAMD Membership:** current and prior AAMD membership beyond 10 years of **consecutive** membership. Do not include the initial 10 years of consecutive membership. Consecutive membership refers to continuous membership therefore if membership lapsed, this calculation would start from the most recent AAMD membership join date. Documentation must be a record from the AAMD database (start and end dates demonstrating consecutive membership).
- 2. Affiliate Organization Membership:** current member of an AAMD affiliate organization. These organizations include ASTRO, AAPM, and ASRT.
