
Poster Contest Winner Provides this Year's Theme

The American Association of Medical Dosimetrists (AAMD) is extremely proud to present the [2022 Outstanding Achievement Award](#) to Dr. Scott Collins. Scott earned his Bachelor of Science in Health Care Management in 1993, Master of Science in Workforce Education and Development in 2001, and Doctorate in Workforce Education and Development in 2011. He received his Medical Dosimetry certification in 1997. He also holds certifications in Radiation Therapy and Radiologic Technology. He has worked at Southern Illinois University for over 20 years. He developed and started the medical dosimetry program there in 2005. Currently, he is the Director of the School of Health Sciences and Program Director of Medical Dosimetry and Radiation Therapy at Southern Illinois University in Carbondale, Illinois.

In his role, Scott has educated numerous medical dosimetry and radiation therapy students and participated in the education of students in the Master of Science program in Radiologic Sciences. He has also directed, organized, and hosted many medical dosimetry review courses preparing students and medical dosimetrists for the board exam.




It's Been a Busy Summer for Medical Dosimetry Students and Educators!

The Formal Education Committee (FEC) hosted 100 attendees, including students, educators, and recent graduates during the annual (virtual) Student Gathering on June 8, 2022. Brian Napolitano, AAMD president, welcomed the attendees and encouraged the students to become involved with the AAMD. The FEC also hosted 18 educators for the Educators' Meeting in Baltimore on June 22. Kristen Vu, director of the medical dosimetry program at Grand Valley State University, presented her research, *Fostering Research Projects with Medical Dosimetry Students*, and Michael Manteuffel discussed updates to the MDCB exam, including the future use of ProKnow contouring tools. Mahsa Dehghanpour, in her capacity as a JRCERT board member, provided information about JRCERT's accreditation site visits during the pandemic and JRCERT's new portal. JRCERT urgently needs site visitors for radiation therapy, medical dosimetry, and magnetic resonance programs. Brian Napolitano, AAMD president, recounted the board's efforts to improve international outreach and to increase access and training for treatment planning systems for educational programs. Lori Simmons outlined the upcoming medical dosimetry curriculum project, a recurring process that will culminate in the publication of updated medical dosimetry education standards in 2024. 
Step Up and Run for Office: The 2023 Call for Nominations Is Open

This July, the committee developed and disseminated a survey that was shared with international professionals around the world. The findings from this survey will help the AAMD identify the training and education needs in each of the countries represented in the survey. Does Your 5-year CMD Cycle End on December 31, 2022?

CMDs whose five-year cycle ends at the end of this year are reminded to submit their learning plan transcripts to confirm completion of CEU requirements.

Please remember to submit your learning plan for completion by November 30 to ensure approval of your learning plan by December 31. Review of learning plans submitted after December 22 may be delayed.

Credential fees can be submitted after October 1 once learning plans are approved. The fees will be submitted on the learning plan that includes 2023.
